College Student Credit Protection Act**

In October 2007, Governor Schwarzenegger signed into law the College Student Credit Protection Act (California Education Code Title III § 99040), which was sponsored by the Greenlining Institute. The text of the law is enclosed.

With respect to the first provision of the law, please provide us – on both a system-wide and campus-by-campus basis – a description of *all exclusive arrangements with banks or other commercial entities to market credit cards to students.*

We understand your office is in the midst of a leadership transition. That said, we would appreciate a response within 10 days from the appropriate representative of the President's office.
