Ibram X. Kendi

Author, *How to Be an Antiracist;* Director, The Antiracist Research and Policy Center, American University

Ibram X. Kendi is a *New York Times* bestselling author and the founding director of The Antiracist Research and Policy Center at American University. A professor of history and international relations, Kendi is a contributing writer at *The Atlantic*. He is the author of *The Black Campus Movement*, which won the W.E.B. Du Bois Book Prize, and *Stamped from the Beginning: The Definitive History of Racist Ideas in America*, which won the 2016 National Book Award for Nonfiction. At 34 years old, he was the youngest ever winner of the NBA for Nonfiction.

Kendi has published numerous essays in academic journals and periodicals, including *The New York Times, The Guardian, Time*, and *The Washington Post*. He has received research fellowships, grants, and visiting appointments from a variety of universities, foundations, professional associations, and libraries, including the American Historical Association, Library of Congress, National Academy of Education, Rutgers Center for Historical Analysis, Brown University, Princeton University, UCLA, and Duke University. Kendi was awarded the prestigious Guggenheim Fellowship and he was honored on The Root 100 in 2019, which listed him as the 15th most influential African American between the ages of 25 and 45 and the most influential college professor.

In August, Kendi's third book, *How to Be an Antiracist*, debuted at no. 2 on the *New York Times* bestseller list and was hailed by the *New York Times* as "the most courageous book to date on the problem of race in the Western mind." It has been named to several Best Books of 2019 lists, including in *The Washington Post*, The *New York Times*, *Time*, and *NPR*. His most recent book, co-authored with Jason Reynolds and released in March, is *Stamped: Racism, Antiracism, and You*, a young adult version of *Stamped from the Beginning*. Kendi lives in Washington, D.C.



Alicia Garza


Principal, Black Futures Lab

Alicia Garza founded the Black Futures Lab to make Black communities powerful in politics. In 2018, the Black Futures Lab conducted the largest survey of Black communities in over 150 years.

Alicia believes that Black communities deserve what all communities deserve -- to be powerful in every aspect of their lives. An innovator, strategist, organizer, and cheeseburger enthusiast, she is the co-creator of #BlackLivesMatter and the Black Lives Matter Global Network, an international organizing project to end state violence and oppression against Black people. The Black Lives Matter Global Network now has 40 chapters in 4 countries.

Alicia serves as the Strategy & Partnerships Director for the National Domestic Workers Alliance, the nation's premier voice for millions of domestic workers in the United States. She is also the co-founder of Supermajority, a new home for women's activism. She shares her thoughts on the women transforming power in *Marie Claire* magazine every month.

Her forthcoming book, tentatively titled *How to Turn a Hashtag Into a Movement* will be published in 2020, and she warns you that hashtags don't start movements. People do.



john a. powell

Director, Othering and Belonging Institute, University of California, Berkeley

john a. powell is Director of the Othering and Belonging Institute and Professor of Law, African American, and Ethnic Studies at the University of California, Berkeley. He was previously the Executive Director at the Kirwan Institute for the Study of Race and Ethnicity at the Ohio State University, and prior to that, the founder and director of the Institute for Race and Poverty at the University of Minnesota. john formerly served as the National Legal Director of the American Civil Liberties Union. He is a co-founder of the Poverty & Race Research Action Council and serves on the boards of several national and international organizations. john led the development of an "opportunity-based" model that connects affordable housing to education, health, health care, and employment and is well-known for his work developing the frameworks of "targeted universalism" and "othering and belonging" to effect equity-based interventions. john has taught at numerous law schools, including Harvard and Columbia University. His latest book is *Racing to Justice:* Transforming our Concepts of Self and Other to Build an Inclusive Society.




